#### **RELAXATIONS/ CONCESSIONS:**

- All criteria mentioned above are for general candidates, however, relaxation of age as per Govt. guidelines shall be applicable for PwBD and Ex-Servicemen candidates. Persons suffering from not less than 40% of the relevant disability shall alone be eligible for the benefit of reservation.
- Candidates belonging to reserved category while applying against UR posts, are required to upload the category certificate in prescribed format of Government of India in support of their claim. If the category certificate has been issued in a language other than English/Hindi, then the candidates will be required to submit a self-certified translated copy of the same in either English or Hindi.
