

PFC Capital Gain Tax Exemption Bonds Series – VIII

Details for RTGS / NEFT Payments

Investors can directly deposit the amount in the PFC's Collection Account by way of NEFT/RTGS and submit the duly filled application in the same bank to which the investor has transferred the funds to. The Beneficiary name to be mentioned in RTGS form is "PFC Capital Gain Bonds". Investor would need to mention the UTR No. at the space provided in the application form for Cheque / Demand Draft / UTR details.
